### First, let's talk about voting...

#### Who's eligible to vote?

Any United States citizen who is 18 years of age or older (or who will be 18 prior to the next election) and, if a felon, is not confined to jail, prison, or another correctional facility, can register to vote.

#### How do I register to vote in Santa Fe?

You can register to vote by 1) requesting a registration application be sent to you by the Santa Fe County Bureau of Elections (505-986-6280), 2) registering in person at the County Clerk's Office, the New Mexico MVD, or a public library, or 3) registering online at [SantaFe.vote](https://SantaFe.vote).

Check your registration status at [SantaFe.vote](https://SantaFe.vote).

#### Do I need to be a registered member of a political party to vote?

To vote in primary elections, held the first Tuesday in June of even-numbered years, you must be a registered member of a major political party. To vote in all other elections, as long as you're registered to vote, you need not to be affiliated with a political party.

**U.S. GOVERNMENT**

**President**

The head of state of the United States of America; the Chief Executive Officer; and, the Commander in Chief of all military forces. The powers of the President are prescribed in the Constitution and federal law. The President appoints the members of the Cabinet, ambassadors to other nations and the United Nations, Supreme Court Justices, and federal judges, subject to Senate approval. The President, along with the Cabinet and its agencies, is responsible for carrying out and enforcing the laws of the United States. The President may also recommend legislation to Congress. The President must be a natural born citizen of the U.S. Elected for a four-year term; may serve no more than two terms.



**Vice President**

Supports the President. If the President is unable to serve, the Vice President becomes President. The Vice President serves as the presiding officer of the Senate. The Vice President must be a natural born citizen of the US.

**U.S. Congress**

The United States Senate and House of Representatives ("Congress") have equal responsibility for declaring war, maintaining the armed forces, assessing taxes, borrowing money, minting currency, regulating commerce, and making all laws and budgets necessary for the operation of government.

**U.S. Senator**

Represents New Mexico in the United States Senate which has 100 members, two from each state. Candidates must be at least 30 years old, a citizen of the United States for at least nine years, and a resident of the state from which elected. Elected statewide for six-year staggered term. The Senate has several exclusive powers, including consenting to treaties, confirming federal appointments made by the President, and trying federal officials impeached by the House of Representatives.

Represents New Mexico in the United States House of Representatives which has 435 members elected from districts based on population. New Mexico is entitled to three members. Candidates must be at least 25 years old, a United States citizen for seven years, and an inhabitant of New Mexico. Elected by district for two-year terms. Santa Fe County is served by the Representative of the Third Congressional District.

**Governor**

Head of the executive branch and the highest state official in

New Mexico. Appoints and supervises directors of executive departments, appoints members of boards and commissions, and signs or vetoes statutes enacted by the Legislature. Must be at least 30 years old, a United States citizen, and have resided continuously in New Mexico for five years preceding his/her election. Elected for a four-year terms with no more than two terms in succession.

**Lieutenant Governor**

Serves as acting Governor when the Governor is out of the state, provides constituent services, presides over the New Mexico Senate and can vote in the event of a tie. In a general election, the Lieutenant Governor is elected jointly with the Governor. Must be at least 30 years old, a United States citizen, and have resided continuously in New Mexico for the five years preceding his/her election. Elected for a four-year term with no more than two terms in succession.

**Secretary of State**

New Mexico's chief elections officer, responsible for overseeing the entire elections process. Regulates lobbyist activity and reporting of campaign finances, and maintains records vital to commerce and industry in New Mexico. Must be at least 30 years old, a citizen of the United States, and have resided continuously in New Mexico for five years preceding his/her election. Elected for a four-year term with

no more than two terms in succession.

**Attorney General**

The state’s legal officer, legal counsel to state government, and guardian of the public interest. Represents the state before courts or agencies and provides legal opinions upon request of the Legislature, state officials or district attorneys. Must be a licensed attorney of the Supreme Court of New Mexico in good standing, at least 30 years old, a citizen of the United States, and have resided continuously in New Mexico for the five years preceding his/her election. Elected to a four-year term with no more than two terms in succession.

**State Auditor**

Assures the financial affairs of every state and local entity are thoroughly examined and audited each year and determines that such audits conducted by independent auditors are made in a competent manner. Must be at least 30 years old, a United States citizen, and have resided continuously in New Mexico for five years preceding his/her election. Elected to a four-year term with no more than two terms in succession.

**Treasurer**

Serves as the state’s banker and is entrusted with receiving, keeping, and disbursing state money; deposits funds in

financial institutions to invest; and oversees the short-term investment fund. Must be at least 30 years old, a United States citizen, and have resided continuously in New Mexico for five years preceding his/her election. Elected to a four-year term with no more than two terms in succession.

Must be at least 30 years of age, a United States citizen, and have resided continuously in New Mexico for five years preceding his/her election. Elected to a four-year term with no more than two terms in succession.

**Public Regulation Commission**

The New Mexico PRC regulates the utilities, telecommunications, and motor carrier industries to ensure fair and reasonable rates, and to assure reasonable and adequate services to the public. The PRC changed from an elected body comprised of five commissioners to an appointed body comprised of three commissioners effective January 1, 2023. **New Mexico State Legislature**

The New Mexico State Legislature is composed of a 70-member House of Representatives and 42-member Senate. During the legislative session, legislators may be reached in Santa Fe. Regular sessions of the Legislature begin on the third Tuesday of January. The Legislature meets for 60 days in odd-numbered years and 30 days in even-numbered years. ### **New Mexico State Judiciary**

Vacancies for courts in New Mexico are filled through appointment by the Governor from a slate of potential nominees submitted by a judicial nominating committee. The newly appointed judge must then run in a contested, partisan election at the next general election. Thereafter, the judge runs in nonpartisan retention elections for set terms. In a partisan election, the candidate receiving the most votes will be elected. In a retention election, the justice or judge must receive a 57% “yes” vote out of all the votes cast on the question of whether the justice or judge should remain in office. ### **State Supreme Court**

The highest court in New Mexico consisting of five justices. It is the court of last resort and has supervisory control over all lesser courts and attorneys licensed in the state. Required to hear appeals from the Public Regulation Commission, election challenges and criminal cases when a defendant is sentenced to the death penalty or life imprisonment. Has discretionary authority to review rulings of the Court of Appeals and questions of law certified to it by the Court of Appeals or federal court. Must be 35 years old, have practiced law for ten years, and have resided in New Mexico for the last three years. Elected statewide for an eight-year term. ### **State Court of Appeals**

An intermediate appellate court between the district courts and the Supreme Court consists of 10 judges who sit in panels of three. Court reviews appeals in all cases, except criminal cases involving sentences of death or life imprisonment, appeals from the Public Regulation Commission, and cases involving habeas corpus. Must be 35 years old, have practiced law for 10 years, and have resided in New Mexico for the last three years. Elected statewide for an eight-year term. **First Judicial District Court**

New Mexico’s 33 counties are divided into 13 judicial districts. The First Judicial District includes Los Alamos, Rio Arriba and Santa Fe counties. These are courts of general jurisdiction that hold jury trials in the following types of civil cases: tort, contract, real property rights and estate contests. The district courts in New Mexico generally have exclusive jurisdiction over domestic relations, mental health, appeals for administrative agencies and lower courts, criminal appeals, and juvenile cases. **First Judicial District Attorney**

The First Judicial District of New Mexico includes Los Alamos, Rio Arriba, and Santa Fe Counties and prosecutes criminal offenses within these counties. The District Attorney handles civil suits involving real estate or claims over \$10,000, juvenile cases, divorce and child custody, criminal felony cases, and appeals from lower courts. Elected for a four-year term.

**SANTA FE COUNTY GOVERNMENT**

County officials are elected to 4-year terms during the partisan general elections. **Santa Fe County Administration Building: 102 Grant Ave. | Santa Fe, NM 87501 | 505-986-6200 | [santafecountynm.gov](http://santafecountynm.gov)**

**County Manager (Appointed)**

Charged with conducting the business of the county and in aiding and assisting in the exercise of the duties and responsibilities of the Board of County Commissioners.

**County Assessor**

Responsible for the tax related valuation of all county property, with certain exceptions, and prepares a periodic property tax schedule. Must be at least 18 years of age and a registered voter and resident of New Mexico.

**County Attorney (Appointed)**

Serves as legal counsel to the Santa Fe County Board of County Commissioners, the County Manager, elected officials, and certain boards and commissions.

**County Clerk**

Must be at least 18 years of age and a resident of the county from which elected. The Clerk is the ex-officio recorder of Santa Fe County and may legally record any document that is certified. The office also issues marriage and occupational licenses. The County Clerk's Bureau of Elections administers



all elections in the County. Must be at least 18 years of age and a resident of the county from which elected.

**County Probate Judge**

Serves the public in exercising jurisdiction over cases of informal probate necessary to the proper settlement of estates of deceased persons. Must be at least 18 years of age and a resident of the county where elected.

**County Sheriff**

Enforces the provisions of all county ordinances; aids in the arrest and detention of escaped prisoners; and serves and executes all process, writs, and orders directed to him/her by magistrate judges and certain others directed by municipal judges. Must be at least 18 years of age and a legal resident and registered voter of New Mexico.

**County Treasurer**

Responsible for collecting property taxes in Santa Fe County and for the supervision and investment of funds. Must be at least 18 years of age and a resident of the county from which elected.
