The following are the Voter Services activities for July 17-August 20, 2024:

Materials: (Rae Dominico, Susan Pfeifer, Kelly Davis)

- Election pamphlet sent to Katharine Clark for approval.
- Materials have been developed and are in various stages of completion.
- Rae Dominico has met with a variety of organizations (over 20) that distribute League materials. She requested them to identify the ones they wanted to display. The materials will be printed and distributed to the organizations by September 1.

Tabling Sites: (Susan Pfeifer)

- Santa Fe Farmers Market: Tabling continues every other week. Numbers served to date 207 includes: 49 registered to vote or asked for registration forums; 42 requests for mail in ballot applications; 116 thank you, comments and general election conversations.
- The Food King: Tabling to start August 31. Committed to every week from the 31st until October 5. After the 5th will be two more tabling events October 19 and November 2.
- NEW TABLING SITES (meeting to get approved of times, dates, etc):
 - Santa Fe Community College serving two sties cafeteria and fitness center.
 - Santa Fe Teen Center in conjunction with the Santa Fe City Libraries. Requested the League to register voters at family night and to participate at other teen center events.

Candidate Forums: (Andrea Slade and Kelly Davis)

- Approval from Santa Fe New Mexican to collaborate on Candidate Forums.
- Secured US Representative District 3 forums October 7. Venue, time still to be determined.
- Contacted US Senate candidates. Working to secure commitment.
- Plan to begin working with District 50 candidates to secure date, time, venue.

Misc:

- <u>St John's Methodist Church Food Pantry</u>: Emailed St Johns Food Pantry to schedule distribution GOTV flyers in English and Spanish for the General Election.
- <u>St Vincent Hospital</u>: Plan on requesting St Vincent Hospital to post a 2024 General Election notice on TV Monitors and in newsletter identifying Vote411 as the source to go to for election information..
- · Voter Guide: See PR Coms report.
- <u>Ballot Measures</u>: Waiting for the County Clerk to post them on the website. Will explore options for analyzing them for possible publication.
- <u>Volunteers</u>: Have an increase in volunteers to register and provide information to individuals. There has been Spanish speakers for the first time wanting to help. Very rewarding experience and allows the League to expand its tabling sites.
- <u>Canvassing and tabling with NAACP</u>: Meeting Friday, August 23 to begin planning canvassing events. I attending NAACP VAN training and have access to the data base. VAN provides lists of current and potential's voters. It enables NAACP to do a variety of activities I.e. postcard, canvassing, phone banking and more. When we partner with NAACP we can be included in these activities. VAN requires every activity to be reported through the MINI VAN app so they can tract numbers serviced.
